restaurant at 3213 Mount Pleasant Street. Ann has been a long-time resident of Mount Pleasant and is very happy to have her newest restaurant located in our neighborhood. Ann and Johnny served us complimentary drinks and appetizers as we enjoyed the lovely new Mexican themed interior and chatting with our neighbors.

Before we ordered our yummy dinner, we heard from the owners about their restaurant business history in DC. They met in 1988 at the original *Austin Grill*, where Ann was executive chef and John the bar manager. They opened the first *Jaleo* restaurant in Penn Quarter in 1993. They opened *Cashion's Eat Place* in Adams Morgan in 1995, where Ann became a James Beard award winner. They also operate *Johnny's Half Shell* on Columbia Road. Ann talked about the quality of the food that she serves; she is particular about making sure her customers have the best food available which is then "cooked with love."

Village Advocates for Seniors and the Mount Pleasant Community

At the October and January Board of Directors meetings resolutions were proposed and passed to support community initiatives that were deemed important for Village members. The October resolution supported, in principle, efforts by Mayor Bowser and others to convert the property at the corner of Kenyon and Mount Pleasant streets, next to the 7-Eleven store, into "Amigos Park," an area with places for people to sit, enjoy the shade, and with tables (some of which could serve as gameboards). Although the designs for the park have not been finalized, it was felt this community space could be a place for people to meet, relax, and enjoy fresh air. The January resolution supported the proposal, drafted by the Village's Waste Management Interest Group, to designate the Mount Pleasant Farmers' Market as a year-round location for food waste drop-offs. The Board felt a central, permanent drop-off site would encourage Village members to participate in the city-wide Zero Waste DC program designed to reduce food waste and provide compost for trees and gardens. Upcoming Event: Author to Discuss His Novel A Particular Kind of Black Man

Tope Folarin, the renowned Nigerian-American author, will talk about his recent book, A Particular

Kind of Black Man, at the Mount Pleasant Library, on Saturday, February 29, at 2:00 pm. In 2013, he won the Caine Prize for African Writing for his short story "Miracle," and, in 2014, was named to the Hay Festival's "Africa39" list of the most promising African writers under 40. His short story "Genesis" was nominated for the 2016 Caine Prize.

Mr. Folarin serves as Vice President of Content and Storytelling at the Local Initiatives Support Corporation. He was educated at Morehouse College and the University of Oxford, where he earned two Masters degrees as a Rhodes Scholar. His debut novel, *A Particular Kind of Black Man*, was published by Simon & Schuster in August 2019, and was read and greatly enjoyed by the Village Ad Hoc Book Club. Mr. Folarin is a resident of the District.

Village and All Souls Church to Co-Sponsor Lecture Series in March

The Village and the Silver Souls seniors' group at All Souls Church Unitarian, will co-sponsor a lecture series on *Preparing to Grow Older Successfully* on the first three Sundays in March. Each session will address issues that we all need to address as we age, with a presentation by experts in the area, followed by Q&A.

The sessions will be held at <u>All Souls Church Unitarian</u>, 1500 Harvard Street NW, from 1:00 to 2:30 pm, following Sunday services. The cost to attend is \$15 per session; \$40 for all three. Tickets can be purchased online; some will be available at the door. The following sessions are scheduled:

On **Sunday March 1:** *Getting Your Affairs in Order* will feature Timothy McDonough, Director of Financial Planning and Team Lead Planner for Garrison Advisors, LLC. He will address the issues needed for planning your life in retirement: What experts should you consult in planning for your future in retirement? What decisions and documents do you need to protect your interests as you grow older? Can you afford to remain retired and what do you need to do to be financially secure?

On **Sunday, March 8:** *Paying for Elder Care,* Chris DeYoung, an experienced consultant on senior healthcare issues with the DC Department of Aging and Community Life (DACL) and former director of the Health Insurance Consulting Project at GW Law School, will address the various healthcare insurance programs available to seniors. These include Medicare, Medicare Advantage, Medicaid, long-term care insurance, and the DACL programs and services for seniors.

On Sunday, March 15, Dixcy Bosley-Smith, a case manager at Iona Senior Services, will discuss the wide variety of housing options for seniors in *Housing Options: More Choices than You Think*. Along with Elizabeth Fox, a founder of Iona, she will discuss some of the options available for aging in your home, co-housing, cooperative living, multigenerational living, independent and assisted living and nursing homes. Village members with experience in alternative housing arrangements are encouraged to come and talk about their experience, ideas and advice.
