In Memoriam

It is with sadness that we report the death of our oldest Villager. Hil Langrall died on November 12, at home, after a long illness and decline. Born and raised in Baltimore, Hil moved into his Lamont Street home in 1965. He served as a Navy Chaplain, as clergy in the United Methodist Church, and after retirement, as Chairman of the Board for Quality of Life Retreats (for persons with HIV/AIDS). He leaves two nephews.

Chocolate City Book Discussion a Fascinating Look at D.C. History

Asked by moderator Mara Cherkasky how he came to write the book, author George Derek Musgrove



revealed that he was scheduled to teach a D.C. history course, but knew very little about the city’s past, nor could he find a single, up to date, text, so he and co-author Chris Myers Asch wrote their own. More than an academic text, it’s a book to be “read and appreciated by neighbors.” Dr. Musgrove discussed how each chapter begins with a D.C. location, provides a description of what it was like in historical context, and its current reality. The chapters were designed tell their stories through the characters of the time, such as Boss Shepherd and Walter Fauntroy. He used Walter Fauntroy as an example of effective D.C. leadership. As the District’s first non-voting delegate to Congress, Fauntroy developed a successful strategy to obtain District home rule and was able to have a

D.C. voting rights amendment to the Constitution passed by congress in 1978, only to have it fail to gain sufficient state support. Dr. Musgrove closed with three points, that statehood will be easier for the District to achieve, requiring only a 51% congressional vote, than a new voting rights amendment, requiring a 75% state ratification vote. That most of the U.S. population is unaware that the District doesn’t have congressional voting rights. And finally, the authors wanted *Chocolate City* to serve as a blueprint for addressing the issues that “devil” the city today – continued racial inequality and growth based on the displacement of the poor, largely African-American population.

Villagers recently gathered for a Meet-the-Street event at Mola restaurant, on Mount Pleasant Street, to enjoy Spanish tapas and conviviality. Owner and general manager McCealaig “Mickey” O’Clisham



described how she and her two partners started the restaurant and their commitment to “buy locally.” Their produce is purchased from local farmers, the Green Hat gin they serve is made in D.C., and a local potter made their entrée dishes. The dining tables were built by one of the partners, and their Andalusian wines are produced by women-owned vineyards. Mola’s menu focuses on Spanish coastal cuisine, featuring fresh vegetables, seafood, and meats. The restaurant’s goal is to



serve delicious food and foster a sense of community. As a measure of their success, Mola received a coveted Michelin Gourmand award this year and will be featured in the 2019 edition of the Michelin dining guide. They also received a high Villager rating.



IRS Rules About Year-End Donations to Mount Pleasant Village

Mount Pleasant Village has been fortunate to receive year-end donations in prior years, which greatly help our ability to provide programs and activities to members. The following IRS rules will help the Village accurately account for your donation and gain you a tax deduction for the current year. If possible, make your donation in time to process it by check or credit card before December 31. The IRS rules are as follows:

- Charitable contributions are deductible in the year that you make the donation.
- When you mail a check, the mailing date of the check determines when the donation can be claimed.
- Credit card donations are deductible in the year that the charity charges your card.
